### **Free Range Balls.**

All members of the Club (excluding Pool and Business Members) are entitled to unlimited free Range Balls for use at the driving range

### **Individual Golfing**

An Individual Golfing Membership entitles one individual full use of the facilities of the Club as well as those same privileges at any semi-private club owned and/or operated by Harris Golf. The individual membership also entitles you to play at Falmouth Country Club for a surcharge. You may play up to 6 times a year but limited to two times in one month.

### **Couple Golfing**

A Member and that Member's Spouse - either a legally married husband and wife, or any two (2) unmarried adults residing in the same house - who acquire a Couple Golfing Membership are entitled to full use of the facilities of the Club as well as those same privileges at any semi-private club owned and/or operated by Harris Golf. The couples membership also entitles you to play at Falmouth Country Club for a surcharge. You may play up to 6 times a year but limited to two times in one month.

### **Family Golfing**

A Family Golfing Membership entitles a Member and that Member's family- either a legally married husband and wife, or any two (2) unmarried adults residing in the same house, and their unmarried children under the age of twenty-two (22) (if residing at home, and attending school on a full time basis) to use the full facilities of the Club as well as those same privileges at any semi-private club owned and/or operated by Harris Golf. A child who has enjoyed continuous, uninterrupted privileges under a f shall be eligible for a membership upgrade to his/her own membership at such time as he/she no longer enjoys privileges under the fair. The family membership also entitles you to play at Falmouth Country Club for a surcharge. Family members may play up to 6 times a limited to two times in one month.

### **Young Adult Golfing**

An Individual Membership entitles one individual age 18 to 35 use of the facilities of the Club as well as those same privileges at any semi-private club owned and/or operated by Harris Golf. A young adult membership also entitles you to play at Falmouth Country Club for a surcharge. You may play up to 6 times a year but limited to two times in one month. A Young Adult Membership shall terminate upon reaching the age of 36. At that time, however, the Young Adult Member may upgrade to Individual Golfing upon payment of the applicable dues.

### **Young Adult Couple Golfing**

A Member and that Member's Spouse- either a legally married husband and wife, or any two (2) unmarried adults residing in the same house- who acquire a Young Adult Couple Golfing Membership and are age 18 to 35 are entitled to full use of the facilities of the Club as well as those same privileges at any semi-private club owned and/or operated by Harris Golf. A young adult couple membership also entitles you to play at Falmouth Country Club for a surcharge. You may play up to 6 times a year but limited to two times in one month. A Young Adult Couple Membership shall terminate upon reaching the age of 36. At that time, however, th Member may upgrade to Individual Golfing upon payment of the applicable dues.

### **Weekday Memberships**

An Individual or Couple Weekday Membership entitles the Member play without green fee and enjoy all the privileges of full membership Monday through Friday only.

## **Twilight Memberships**

An Individual Twilight Membership entitles the Member play without green fee and enjoy all the privileges of full membership after 3:00 pm any day of the week .

## **Social Memberships**

An Individual, Couple or Family Social Membership entitles the Members to use all of the facilities of the Club, except for golf. Golf privileges will be available at the member's guest rate to all Social members. Social Members will not be eligible for Club tournaments and league play.

## **Business**

A business Membership is available to any bona fide ongoing business entity (partnership, company, trust or other entity) that has been in legal existence for more than one year. A business that is formed for the purpose of purchasing a Business Membership shall not qualify as a bona fide ongoing business for the purpose of this Plan. The holder of a Business Membership may use the passes or transfer them to any business related associate.

## **Corporate**

A Corporate Membership is available to any bona fide ongoing business entity (partnership, company, trust, or other entity) that has been in legal existence for more than one year. A business that is formed for the purpose of purchasing a Corporate Membership shall not qualify as a bona fide ongoing business for the purpose of this Plan. The holder of a Corporate Membership may designate in writing up to one (1) bona fide principal, partner, director, officer, shareholder or employee, or a beneficiary or settlor if the membership is held in the name of a trust, as Designee along with his or her spouse, each of whom shall complete an informational application and be above the age of eighteen (18). A Corporate Member may designate a new Designee under the membership each year by making a request in writing once each year before April 1st. The Designee, or any substitute Designee, shall be subject to approval of the Club. The Designee and the Corporate Member business entity shall be jointly and severally liable for all fees and other charges incurred by the Designee and any of their guests. The Designee may bring guests to use the Club Facilities. Each Corporate Member may sponsor unaccompanied guests per diem, subject to tee-time availability and the discretion of the Club management.

## **Student Golfing**

A Student Membership is a restricted membership that allows full-time students up to the age of 23 years to utilize the full Club facilities on a restricted basis with same-day only tee times and limited access to Club events. Student members will be required to pay the upgrade fee to the Individual Golfing membership status by the date of their twenty fourth (24) birthday or when full-time student status is no longer maintained.

## **Student Golfing Seasonal**

A Student Golfing Membership is a restricted membership that allows full-time students up to the age of 23 years to utilize the full Club facilities on a restricted basis with same-day only tee times and limited access to Club events from Club opening to Memorial Day and from Labor Day to Season's end. Student members will be required to pay the upgrade fee to the Individual Golfing membership status by the date of their twenty fourth (24) birthday or when full-time student status is no longer maintained.

Member agrees to accept any and all risk of injury to Member and Member's family members and guests which may be sustained while using the Club facilities or involved in any event or activity incident to membership. Member further agrees to indemnify the Club and to hold the Club (and its managers, directors, officers, principals, employees, agents, and other representatives) harmless from and against any loss, cost, injury, damage or liability sustained or incurred by Member, Member's family members, or Member's guests resulting from or arising directly or indirectly out of any conduct or event or omission connected with Membership in the Club and/or use of any Club facilities.
